What is this policy for?

- We understand that your privacy is important to you and that you care about how your personal

Who is this policy for?

This policy applies to anyone who visits our website.

Definitions and interpretations

In this Policy, the following terms shall have the following meanings:

areas and features of Our Site.

"Cookie" Means a small text file placed on your computer or device by

Our Site when you visit certain parts of Our Site and/or when you use certain features of Our Site. Details of the Cookies

used by Our Site are set out below.

"Cookie Law" Means the relevant parts of the Privacy and Electronic

Communications (EC Directive) Regulations 2003.

"Personal Data" Means any and all data that relates to an identifiable person

who can be directly or indirectly identified from that data. In this case, it means personal data that you give to Us via Our Site. This definition shall, where applicable, incorporate the definitions provided in the EU Regulation 2016/679 – the

General Data Protection Regulation ("GDPR"); and

"We/Us/Our" Means Suburban Inns, a limited company registered in

England under company number 12528673, whose registered address is Ventura House, Ventura Park Road,

This Privacy Policy applies only to your use of Our Site. Our Site may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.

Your rights

As a data subject, you have the following rights under the GDPR, which this Policy and Our use of personal data have been designed to uphold:

- The right to be informed about our collection and use of personal data.
- The right of access to the personal data we hold about you.
- The right to rectification if any personal data we hold about you is inaccurate or incomplete.
- The right to be forgotten i.e. the right to ask us to delete any personal data we hold about you (we only hold your personal data for a limited time, but if you would like us to delete it sooner, please contact us using the details in this policy).
- The right to restrict (i.e. prevent) the processing of your personal data.
- The right to data portability (obtaining a copy of your personal data to re-use with another service or organisation).
- The right to object to Us using your personal data for particular purposes; and
- Rights with respect to automated decision making and profiling.

What do we collect?

Depending upon your use of Our Site, we may collect some or all of the following personal and non-personal data:

- Name.
- Address.
- Job title.
- Professional history.
- Contact information such as email addresses and telephone numbers.
- Demographic information such as post code and interests.
- Salary expectations.

How do we use your data?

All personal data is processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with our obligations and safeguard your rights under the GDPR at all times.

Our use of your personal data will always have a lawful basis, either because it is necessary for our performance of a contract with you, because you have consented to our use of your personal data (e.g. by subscribing to emails), or because it is in our legitimate interests. Specifically, We may use your data for the following purposes:

- Helping you to secure permanent employment.
- Helping you to secure temporary work.
- Advising you on CV preparation.
- Supplying our services to you (please note that we require your personal data in order to enter into a contract with you).
- Replying to emails from you.
- Analysing your use of Our Site to enable Us to continually improve Our Site and your user experience.

With your permission and/or where permitted by law, we may also use your data for marketing purposes which may include contacting you by email and telephone and text message and post with information,

news, and possible job roles. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that we fully protect your rights and comply with our obligations under the GDPR and the Privacy and Electronic Communications (EC Directive) Regulations 2003.

Third parties (including Toggle, DesignMyNight, TicketTailor) whose content appears on Our Site may use third party Cookies, as detailed below. Please note that we do not control the activities of such third parties, nor the data they collect and use and advise you to check the privacy policies of any such third parties.

You have the right to withdraw your consent to us using your personal data at any time, and to request that we delete it.

We do not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected.

How and where do we store your data?

We only keep your personal data for as long as we need to in order to use it as described above, and/or for as long as we have your permission to keep it.

Your data will only be stored in the UK.

Data security is very important to us, and to protect your data we have taken suitable measures to safeguard and secure data collected through Our Site.

Steps we take to secure and protect your data include:

We are committed to ensuring your information is secure. We have put in place across our business suitable physical, electronical and managerial procedures to help safeguard and secure the information we collect online. Do we share your data?

We may share your data with other companies for the processing of payroll if you are working with us as a Temporary Worker.

We may share your data with clients of ours who are interested in hiring staff. Where any of your data is required for such a purpose, we will take all reasonable steps to ensure that your data will be handled safely, securely, and in accordance with your rights, our obligations, and the obligations of the third party under the law.

We may compile statistics about the use of Our Site including data on traffic, usage patterns, User numbers and other information. All such data will be anonymised and will not include any personally identifying data, or any anonymised data that can be combined with other data and used to identify you.

In certain circumstances, we may be legally required to share certain data held by us, which may Include your personal data, for example, where we are involved in legal proceedings, where we are complying with legal requirements, a court order, or a governmental authority.

What happens if our business changes hands?

We may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of our business. Any personal data that you have provided will, where it is relevant to any part of our business that is being transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Privacy Policy, be permitted to use that data only for the same purposes for which it was originally collected by.

In the event that any of your data is to be transferred in such a manner, you will be contacted in advance and informed of the changes.

How can I control my data?

When you submit personal data via Our Site, you may be given options to restrict our use of your data. Our use of cookies
